#### **Running order of the trial:**

The drawing of entries for all classes will take place on the field trial grounds at 8:00 AM. Dogs must be present on the field trial grounds at the time of the drawing to be officially entered. OAAD & OAAB classes will run on consecutive days. Bitches in season are eligible to run in the OAAB class. The winners of all classes will run, if eligible, for absolute. The field trials will be held regardless of weather.

**DIRECTIONS TO HUNT TEST GROUNDS –**

***PLEASE Check for current road closures***

From I-25

Exit Interquest Parkway

East on Interquest Parkway – Hwy 83

Exit right onto Powers Blvd. – Hwy 21

South on Powers Blvd.

Exit E. Woodmen Road

Left going East on E. Woodmen Road (past St. Francis Medical Center on the right)

Go to the end of E. Woodmen road to the stop light at Hwy 24

Left on Hwy 24

Go through the town Peyton (Watch speed limit)

Go through the town Calhan (Watch speed limit)

Next town is Ramah (the blue and white water tower on the left and Ramah cemetery on the right)

Right onto Ramah Road, go past the cemetery on the right, around the bend, and to the stop sign.

Mishka's House, with big green roof, is at the stop sign on the left.

**DIRECTIONS FROM THE HOST HOTEL –**

I70 east to Limon. Exit at Limon (Highway 24) and go south 26 miles to Ramah Highway (approx 3 miles past Simla). Passing through Matheson and Simla - watch the speed limits! Left on Ramah Highway 1 mile. Grounds are on the corner of Ramah Road and Ramah Highway - house with green roof on the left. I think you're using directions from Colorado Springs coming in from the south.
